S-08 **Completing an unfinished sentence**

The sentence is entered into the registry under the name of the citizen who completed it.

S-09 **Reporting that something has changed**

Reclassified as Improvement. No further action required.

S-10 **Unauthorised optimism**

Recorded. Not penalised. Recorded.

S-11 **Failure to present the credential**

The number is retained. The holder is not.

S-12 **Repeated compliance**

Compliance is expected. Repetition of the expected is not an infraction. Recorded nonetheless.

The first answer is withdrawn.

- S-05 **Predicting the weather**
Fine: €47. Payable in past tense.
- S-06 **Unauthorised use of the number 835**
Reserved. See Proposal 006.
